

Differences in the ISO 2022 camt messages between Version 2013 and 2019

What's it all about?

On 21 November 2022, the new ISO Version 2019 (schema: camt.05x.00x.08) will be introduced in the Swiss financial center. This affects all camt messages.

PostFinance offers a transition period until November 2026. By then, the processing systems must be able to handle the new ISO Version 2019.

The following differences exist at PostFinance in the camt messages from the new Version 2019 compared to current Version 2013.

1. Additional Information

The field <AddtlInf> is delivered with new content (in each case with the current IG Version).

2. Reporting Source

This element is no longer used.

ISO Element

Stmnt +RptgSrc ++Prtry	Is not delivered



3. Account Currency

The field <Ccy> is now delivered and indicates the currency in which the account is held.

ISO Element

4. Code for booking status

Amendment of sub-element for the status: the value BOOK is now delivered in sub-element <Cd> and no longer in element <Sts>.

Ntry +Sts	Ntry +Sts ++Cd

5. Unique End-to-end Transaction Reference (UETR)

The field Unique End-to-end Transaction Reference (UETR) is now delivered. This is always assigned by PostFinance; even if a UETR generated by the originator is delivered in pain.001. The UETR from the interbank payment transactions is adopted 1:1.

6. Subelement Party

The new subelement <Party> always appears after <Debtor>, <Ultimate Debtor>, <Creditor> und <Ultimate Creditor>.

The different camt messages for an account do not have to be in the same ISO Version.

The order for migration to the new ISO Version can be placed as follows:

- Telephone call/e-mail to your personal customer advisor
- Hotline for business customers: +41 58 448 14 24
- Registration and change form – electronic account documents

Please allow sufficient time for the transition from order placement.
