

What's it all about?

As of 18 November 2022, the new ISO Version 2019 will be introduced in the Swiss financial center. Pain.001 is now mapped in the SPS schema "pain.001.001.09.ch.03.xsd", and pain.002 is based on the ISO 20022 XML schema "pain.002.001.10". PostFinance offers a transition period until November 2026. By then, the processing systems must be able to handle the new ISO Version 2019.

The following updates apply to pain messages:

1. New payment methods

With the discontinuation of inpayment slips (ISR/IS), the previous payment methods will be simplified as follows:

2. Extension of the character set

SPS 2022 introduces an extension of the character set. This includes the printable characters of the following Unicode blocks:

- Basic Latin (Unicodepoint U+0020 U+007E)
- Latin-1 Supplement (Unicodepoint U+00A0 U+00FF)
- Latin Extended-A (Unicodepoint U+0100 U+017F)

And in addition the following characters:

- Ş (LATIN CAPITAL LETTER S WITH COMMA BELOW, Unicodepoint U+0218)
- ş (LATIN SMALL LETTER S WITH COMMA BELOW, Unicodepoint U+0219)
- T (LATIN CAPITAL LETTER T WITH COMMA BELOW, Unicodepoint U+021A
- t (LATIN SMALL LETTER T WITH COMMA BELOW, Unicodepoint U+021B)
- € (EURO SIGN, Unicodepoint U+20AC)

Procedure for migration of pain messages from Version 2009 to Version 2019

No registration is necessary for the changeover of the pain message to the new ISO Version 2019. During the transition phase up until November 2026, PostFinance will accept pain.001 orders in both versions. The pain.002 response is automatically created in the same way as the pain.001 message version submitted.
